(1) On July 5, 2007, Mr. Schwartz was granted stock options with respect to a total of 10,258 shares of the Issuer's common stock. The grant price for the stock options is \$20.83 per share of common stock. The stock options will vest at a rate of 25% per year on each of the first four anniversary dates from the date of grant. They will expire on the earlier of (i) sixty days after the date Mr. Schwartz is no longer a Director of the Issuer, or (ii) seven years from the date of grant.
