 Grant of Incentive Stock Options to acquire 3,000 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Stock Option Plan of 2000. Options become exercisable with respect to 444 shares on 2/22/2006 and in 6 annual increments of 426 shares beginning on 2/22/2007 at an option price of \$27.75. These options expire on 2/22/2015.
