On November 14, 2018, Florida Power & Light Company sold \$99,330,000 principal amount of its Floating Rate Notes, Series due November 14, 2068 (Notes). The Notes bear interest at a rate equal to three-month LIBOR minus 0.30%, which rate will be reset quarterly on February 14, May 14, August 14, and November 14 of each year, beginning February 14, 2019. The Notes were registered under the Securities Act of 1933 pursuant to Registration Statement Nos. 333-226056, 333-226056-01 and 333-226056-02. This Current Report on Form 8-K is being filed to report as exhibits certain documents in connection with the sale of the Notes.
