Item 2.02 Results of Operations and Financial Condition.

On April 23, 2013, Arrhythmia Research Technology, Inc. (the "Company") announced its preliminary financial results for the twelve months ended December 31, 2012 together with an explanation for the delay in filing its annual report on Form 10-K for the year ended December 31, 2012. The full text of the press release issued in connection with the announcement is furnished as Exhibit 99.02 to this Current Report on Form 8-K.

On May 17, 2013, the Company announced its preliminary financial results for the three months ended March 31, 2013 together with an explanation for the delay in filing its interim report on Form 10-Q for the quarter ended March 31, 2012. The full text of the press release issued in connection with the announcement is furnished as Exhibit 99.03 to this Current Report on Form 8-K.

The information in this Item 2.02 and Exhibits 99.02 and 99.03 attached hereto shall not be deemed "filed" for purposes of Section 18 of the Securities Exchange Act of 1934 (the "Exchange Act") or otherwise subject to the liabilities of that section, nor shall it be deemed incorporated by reference in any filing under the Securities Act of 1933 or the Securities Exchange Act of 1934, except as expressly set forth by specific reference in such a filing.

Item 3.01 Notice of Delisting or Failure to Satisfy a Continued Listing Rule or Standard; Transfer of Listing.

By letter dated April 17, 2013, the NYSE MKT LLC (the "Exchange") notified Arrhythmia Research Technology, Inc. (the "Company") that it is not in compliance with certain of the Exchange's continued listing standards as set forth in Sections 134 and 1101 of the Exchange's Company Guide (the "Company Guide") as a result of the failure to file its annual report on Form 10-K on a timely basis. The Company has therefore become subject to the procedures and requirements of Section 1009 of the Company Guide. Such procedures require the Company to communicate with the Exchange by April 23, 2013 to confirm receipt of the letter and indicate whether or not it intends to submit a plan of compliance. The Company intends to submit a plan of compliance to the Exchange by May 1, 2013 in accordance with the notice advising the Exchange of action it has taken or intends to take that will bring the Company into compliance with Sections 134 and 1101 of the Company Guide by no later than July 16, 2013. If the plan is accepted but the Company is not in compliance with the continued listing standards of the Company Guide by July 16, 2013 or if the Company is not making progress consistent with the plan, the Company may be subject to delisting procedures. On April 23, 2013, the Company issued a press release regarding the notice. A copy of the Company's press release is attached hereto as Exhibit 99.01.

On May 30, 2013, the Company filed its annual report on Form 10-K with the Securities and Exchange Commission. By letter dated May 17, 2013, the Exchange notified the Company that it is not in compliance with certain of the Exchange's continued listing standards as set forth in Sections 134 and 1101 of the Company Guide as a result of the failure to file its interim report on Form 10-Q on a timely basis. The Company has therefore become subject to the procedures and requirements of Section 1009 of the Company Guide. Such procedures require the Company to communicate with the Exchange by May 31, 2013 to confirm receipt of the letter and indicate whether or not it intends to submit a plan of compliance. The Company submitted a plan of compliance to the Exchange by May 31, 2013 in accordance with the notice advising the Exchange of action it has taken or intends to take that will bring the Company into compliance with Sections 134 and 1101 of the Company Guide by no later than August 16, 2013. If the plan is accepted but the Company is not in compliance with the continued listing standards of the Company Guide by August 16, 2013 or if the Company is not making progress consistent with the plan, the Company may be subject to delisting procedures.

On May 31, 2013, the Company issued a press release regarding the additional Exchange notice. A copy of the Company's press release is attached hereto as Exhibit 99.04.
