ITEM 9. REGULATION FD DISCLOSURE

The RICHMOND has been awarded a contract by Bois D' Arc Offshore Ltd. ("Bois") to drill one well plus deepen one well and complete four wells. The rig will move to the first Bois drilling location immediately upon completing its current contract with Union Oil Company of California, which should be completed in late March 2004. The Bois drilling program should take approximately 90 days to complete and will have a dayrate of \$26,000.

Additional information with respect to the Company's Contract Status Summary at March 9, 2004 is attached hereto as Exhibit 99.1 which is being furnished in accordance with Rule 101(e)(1) under Regulation FD and should not be deemed to be filed.
