Basket: The notes are linked to an equally weighted basket consisting of the following:

- 50.00% of the Russell 2000® Index; and
  - 50.00% of the EURO STOXX 50® Index
- (each an “Index” and together, the “Indices”).

Observation Date: December 22, 2023

Maturity Date: December 29, 2023

Participation Rate: At least 118.00%\*

Additional Amount:  $\$1,000 \times \text{Basket Return} \times \text{Participation Rate}$ , provided that the Additional Amount will not be less than zero.

Payment At Maturity: At maturity, you will receive a cash payment, for each \$1,000 note, of \$1,000 plus the Additional

Amount, which may be zero.
