- (1) Disposed of pursuant to merger agreement between issuer and Bank of Montreal ("BMO"), pursuant to which, effective July 5, 2011, Marshall & Ilsley Corporation merged with and into a subsidiary of BMO (the "Merger"), in exchange for 29,792 shares of BMO common stock having a market value of \$63.15 per share.
 - (2) Disposed of pursuant to merger agreement between issuer and Bank of Montreal ("BMO") in exchange for 6,080 shares of BMO common stock having a market value of \$63.15 per share.
 - (3) This option provided for vesting in three equal installments beginning 10/29/2009. Vesting was accelerated to the effective time of the Merger and the option was assumed by BMO in the Merger and replaced with an option to purchase 8,698 shares of BMO common stock for \$148.45 per share.
 - (4) This option, which vested in three equal installments beginning 10/19/2008, was assumed by BMO in the Merger and replaced with an option to purchase 7,558 shares of BMO common stock for \$249.82 per share.
 - (5) This option, which vested in three equal installments beginning 6/19/2007, was assumed by BMO in the Merger and replaced with an option to purchase 10,077 shares of BMO common stock for \$266.19 per share.
 - (6) This option, which vested in three equal installments beginning 10/30/2007, was assumed by BMO in the Merger and replaced with an option to purchase 5,038 shares of BMO common stock for \$286.20 per share.

On July 5, 2011, Bank of Montreal ("BMO") and Marshall & Ilsley Corporation ("M&I") completed their previously announced merger.
