Aranda is wholly owned by Seletar Investments Pte Ltd, which in turn is wholly owned by Temasek Capital (Private) Limited ("Temasek Capital"). Tembusu Capital and Temasek Capital are each wholly owned by Temasek Holdings (Private) Limited ("Temasek Holdings"). Therefore, as of April 2, 2018, Temasek Holdings may be deemed to beneficially own the 110,544,205 shares of Common Stock beneficially owned in aggregate by Tembusu Capital and Temasek Capital.
