**CGGVeritas acquires minority interest in Eastern Echo**

Paris, November 12, 2007

CGGVeritas (ISIN: FR0000120164 NYSE: CGV) announced today that it has acquired 30.9 million shares of Eastern Echo Holding plc (ECHO NO) for a total consideration of approximately NOK 431 million, representing 12.67 percent of Eastern Echo's issued share capital.

Our intent, with this minority stake, is to best position the CGGVeritas Group, and especially Sercel, for continuing cooperation with Eastern Echo in the expanding seismic market.
