In the previously made announcements, our Company had informed that, in relation to the written statement of the Telecommunications Authority regarding the signing of a national roaming agreement with the GSM 1800 companies, an arbitration proceeding had been initiated before the ICC arbitration court and that the proceeding had not been accepted stating that the subject was not under its authority. The suit we have initiated in order for the annulment of the decision of the ICC International Arbitration Court Judge Committee had also been rejected and this decision had been appealed by our Company.

Supreme Court of Appeals' 11th Section, after examination of our application, has accepted our appeal by a decision we have received on January 26, 2006 and so decided that the ruling has been annulled in favor of our Company.
