Istanbul Stock Exchange **ISTANBUL Special Subjects**: We had announced on our Board of Directors meeting dated February 27, 2009 that our Board of Directors had decided to assure export financing up to US\$750 million to be used for the 2G and 3G network related expenditures of Turkcell Group Companies. Accordingly, an agreement has been signed in order to provide export financing for the goods and services, which will be purchased from Ericsson AB and Ericsson Telekomünikasyon A.S. in the amount of approximately US\$285 million. The financing will be made through Calyon Credit Agricole Bank and Nordea Bank with partial or total guarantee of Swedish Export Credits Guarantee Board and assured from The Swedish Export Credit Corporation. The financing will be unsecured with a cost of approximately 4% -4.25%, maturity of 5 years, and semiannual payments.
