(a) and (b) Based upon an aggregate of 4,022,774 shares of Common Stock outstanding as determined by the Issuer's most recently available 10Q filing, as of the close of business on November 4, 2015:

- (i) MHFII beneficially owned 154,700 shares of Common Stock, constituting approximately 3.8% of the shares outstanding.

- (ii) Holdings owned directly no shares of Common Stock. By reason of its position as general partner of certain partnerships, including MHFII, Holdings may be deemed to beneficially own the 201,200 shares of Common Stock which are held by such partnerships, constituting approximately 5.0% of the shares outstanding.

- (iii) MCM owned directly no shares of Common Stock. By reason of its position as investment advisor, MCM may be deemed to beneficially own the 255,000 shares of Common Stock which are held of record by clients of MCM, constituting approximately 6.3% of the shares outstanding.

- (iv) Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of MCM, Mr. Maltese may be deemed to beneficially own 255,000 shares of Common Stock, constituting approximately 6.3% of the shares outstanding.
