Item 5.03. Amendments to Articles of Incorporation or Bylaws: Change in Fiscal Year.

On January 26, 2007, the Board of Directors of Alabama Power Company (the Company) amended the Company's By-Laws (the Amended By-Laws). Prior to the amendment, the By-Laws specified that the annual meeting of stockholders be held on the fourth Friday in April of each year and, if a legal holiday, then on the following Friday. The Amended By-Laws added to such provision that the Board of Directors may designate a date for the annual meeting of stockholders other than the date specified in April. The Amended By-Laws became effective on January 26, 2007.

The paragraph above contains only a summary description of the Amended By-Laws and is qualified in its entirety by reference to the full text of the Amended By-Laws, which is attached as Exhibit 3(b)2 hereto and incorporated herein by reference.
