NEW YORK, NY, Oct. 11 - The Board of Directors of EIS Fund (NYSE: EIS) today announced that it convened its Annual Shareholder's Meeting on Oct. 8, 2001, conducted scheduled business and adjourned the meeting until Oct. 30, in order to allow votes cast at the meeting to be tabulated, and to determine whether a quorum was present.
