Filing History Related to the Plan

First Horizon National Corporation (“FHNC,” the “Corporation,” or the “Registrant”) previously filed registration statements on Form S-8 (File Nos. 333-109862, 333-123404, 333-133635, 333-166818, and 333-181162), registering (before adjustment for stock dividends) 3,000,000, 1,000,000, 4,500,000, 3,000,000, and 8,000,000 (respectively) shares of its common stock, par value \$0.625 per share, that may be issued under FHNC’s Equity Compensation Plan (as amended and restated to date, the “Plan”), formerly known as FHNC’s 2003 Equity Compensation Plan. All such amounts are stated before adjustment for stock dividends declared from 2008 through 2010.

FHNC is filing this registration statement to register 6,500,000 additional shares of FHNC’s common stock that may be issued under the Plan pursuant to an amendment effective April 26, 2016 (approved by the shareholders on that date). That amendment increased by 6,500,000 the maximum number of shares authorized for issuance under the Plan.

PART I

The Section 10(a) prospectus relating to the Plan is omitted from this Registration Statement pursuant to the Note to Part I of Form S-8.

Item 5. Interests of Named Experts and Counsel

The validity of shares of \$0.625 par value common stock of FHNC ("shares") which may be issued pursuant to the Plan has been passed upon by John A. Niemoeller, Senior Vice President, Counsel, and Assistant Corporate Secretary of FHNC. As of April 29, 2016, Mr. Niemoeller beneficially owned approximately 18,114 shares. That number includes shares owned outright and within vested retirement plan accounts, and shares that may be issued or become vested in the future under all unvested stock-based or stock-payable employee awards. All such unvested awards have been counted for this purpose as if they had fully vested as of April 29, 2016 without reduction for applicable withholding taxes.

Item 6. Indemnification of Directors and Officers

Tennessee Code Annotated Sections 48-18-501 through 48-18-509 authorize a corporation to provide for the indemnification of officers, directors, employees and agents in terms sufficiently broad to permit indemnification under certain circumstances for liabilities (including reimbursement for expenses incurred) arising under the Securities Act of 1933, as amended. FHNC has adopted the provisions of the Tennessee statute pursuant to Article Six of its Bylaws. In addition, FHNC has a directors' and officers' liability insurance policy which provides coverage sufficiently broad to permit indemnification under certain circumstances for liabilities (including reimbursement for expenses incurred) arising under the Securities Act of 1933, as amended.

Tennessee Code Annotated, Section 48-12-102, permits the inclusion in the charter of a Tennessee corporation of a provision, with certain exceptions, eliminating the personal monetary liability of directors to the corporation or its shareholders for breach of the duty of care. FHNC has adopted the provisions of the statute as Article 13 of its charter.

The shareholders of FHNC have approved a provision in Article Six of FHNC's Bylaws pursuant to which FHNC is required to indemnify each director and any officers designated by the Board of Directors, and advance expenses, to the maximum extent not prohibited by law. In accordance with the foregoing, the Board of Directors is authorized to enter into individual indemnity agreements with the directors and such officers. Such indemnity agreements have been approved for all of the directors and certain officers.
