On April 24, 2015, the issuer declared a cash dividend of \$0.11 per share of common stock, payable June 26, 2015 to all shareholders of record on June 12, 2015 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, January 2, 2014, August 25, 2014 and January 2, 2015, 245, 96, 156 and 301 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 245 shares in even increments over 3 years beginning January 2, 2016, 96 shares in even increments over 4 years beginning January 2, 2016, 156 shares in even increments over 5 years beginning August 25, 2015 and 301 shares in even increments over 5 years beginning January 2, 2016.
