The additional shares of restricted stock will vest as follows: 58 shares in even increments over 3 years beginning January 2, 2016, 56 shares in even increments over 4 years beginning January 2, 2016, 175 shares in even increments over 5 years beginning August 25, 2015 and 157 shares in even increments over 5 years beginning January 2, 2016.
