CVS Health has agreed to acquire Aetna. This combination advances our strategy of being a leader in the future of health care and supports our goal of helping members achieve their best health.

Why is this combination good for consumers?

CVS Health and Aetna are joining to revolutionize the consumer health care experience. Our new company will use CVS Health's 9,700 retail stores for entirely new community health hubs dedicated to improving consumer wellbeing and answering questions about healthy prescription drugs and healthcare benefits.

Should we expect any changes in the products and services I get from Aetna as a result of this acquisition?

There are no changes at this time to the products and services we offer. Over the longer-term our products will continue to evolve. As always, we will communicate any changes that affect you.

Will this change Aetna's commitment to the joint venture model?

We do not anticipate any changes to the JV model or to our commitment to our JV partners. The joint venture model is critical to our advance provider partnership strategy. As always, we will communicate any changes that affect you.
