CVRD settles 2007 pellet prices with Posco

Rio de Janeiro, January 17, 2007 Companhia Vale do Rio Doce (CVRD), the world's largest iron ore producer, has concluded the blast furnace pellet price negotiations for 2007 with POSCO, one of the the largest Asian steel makers. As an outcome of these negotiations, the blast furnace pellet prices FOB Tubarão and Ponta da Madeira, increased by 5.28% relatively to the 2006 reference prices.

Despite the sharp rise in costs, CVRD continues to invest a substantial amount of resources to add new capacity of high quality pellets to meet client needs in the near future, consistently with its strong long-term commitment.
