On May 4, 2003, CEL-SCI sold 6,402,435 shares of its common stock to a private investor for \$5,250,000 or \$0.82 per share. As part of this transaction, Wachovia Capital Markets, LLC, the placement agent in the offering, received from CEL-SCI a cash commission of \$315,000, or 6% of the gross offering price for the shares sold, as well as warrants to purchase 76,642 shares of CEL-SCI's

common stock at a price of \$1.37 per share at any time prior to May 4, 2009. CEL-SCI also paid certain legal fees and other expenses incurred by the placement agent which are estimated to be \$75,000.
