- (1) Directors may elect to receive a portion of their annual compensation in the form of restricted common shares, par value \$1.00 per share of MF Global Ltd. (the "Restricted Shares"). Restricted Shares are subject to the terms and conditions of the MF Global Ltd. Amended and Restated 2007 Long Term Incentive Plan and vest in equal installments on the last day of each fiscal quarter of service following the date of grant, with vesting subject to continued service during each fiscal quarter. Of the 38,535 common shares beneficially owned by the reporting person, 11,244 are Restricted Shares, which vest in four equal installments on the last day of each of the four fiscal quarters of service following their grant date, with vesting subject to continued service during each fiscal quarter.
