As of December 31, 2004, Mr. Wetherell beneficially owned 32,238,218 shares of the common stock of CMGI, Inc., which includes: (i) 5,074,980 shares which may be acquired upon the exercise of options that are exercisable within 60 days after December 31, 2004, (ii) 16,812,672 shares held by North Andover LLC, of which Mr. Wetherell owns a membership interest and which is managed by a limited liability company of which Mr. Wetherell owns a membership interest, and (iii) 7,588,500 shares held by ElBrillo Holdings, LLC of which Mr. Wetherell owns a membership interest and which is managed by a limited liability company of which Mr. Wetherell owns a membership interest. Mr. Wetherell disclaims beneficial ownership of the 16,812,672 shares held by North Andover LLC and the 7,588,500 shares held by ElBrillo Holdings, LLC, and the filing of this report shall not be deemed an admission by Mr. Wetherell that he is the beneficial owner of such shares.
