As previously reported, on September 28, 2012, the reporting person received a grant of 37,500 restricted units that vest ratably on each of the first, second and third anniversaries of the date of grant. The first anniversary occurred on September 27, 2013, resulting in the
- (2) vesting and settlement of 12,500 shares of common stock, as shown in Table I. The remaining 25,000 restricted units are shown in Table II, of which 12,500 are scheduled to vest on September 28, 2014 and 12,500 are scheduled to vest on September 28, 2015. Restricted units are settled in shares of the Company's common stock upon vesting.
